About the International POPs Elimination Project

On May 1, 2004, the International POPs Elimination Network (IPEN http://www.ipen.org) began a global NGO project called the International POPs Elimination Project (IPEP) in partnership with the United Nations Industrial Development Organization (UNIDO) and the United Nations Environment Program (UNEP). The Global Environment Facility (GEF) provided core funding for the project.

IPEP has three principal objectives:

- Encourage and enable NGOs in 40 developing and transitional countries to engage in activities that provide concrete and immediate contributions to country efforts in preparing for the implementation of the Stockholm Convention;
- Enhance the skills and knowledge of NGOs to help build their capacity as effective stakeholders in the Convention implementation process;
- Help establish regional and national NGO coordination and capacity in all regions of the world in support of longer term efforts to achieve chemical safety.

IPEP will support preparation of reports on country situation, hotspots, policy briefs, and regional activities. Three principal types of activities will be supported by IPEP: participation in the National Implementation Plan, training and awareness workshops, and public information and awareness campaigns.

Expert team and capacity building on POPs in Mexico

This project conducted activities incorporating an expert team in order to increase knowledge and skills about POPs at the local level and build capacity for a more effective public participation in the National Implementation Plan (NIP). This campaign included the preparation of a national workshop to build capacity among NGOs and grassroots organizations around the country; the production of a CD of the proceedings, the elaboration and distribution of a fact sheet and a poster and recommendations regarding the creation of the National Coordination Committee to the Stockholm Convention.

The activities performed in the IPEP project were:

SEMINAR-WORKSHOP ON PERSISTENT ORGANIC POLLUTANTS AND ZERO WASTE: REFLECTIONS FROM CIVIL SOCIETY

This activity was conducted in México City on November 18 and 19, 2005, with the participation of 50 people from 32 institutions, environmental groups, and grassroots organizations from 10 states from the interior of Mexico (Veracruz, Chihuahua, Sonora, Tlaxcala, Hidalgo, México, DF, Morelos, San Luis Potosí, and Guanajuato). At the seminar were experts participating in IPEN, The Global Alliance of Incineration Alternatives (GAIA) based in Argentina and the Energy Justice Network from USA. There were also presentations from local organizations about their experiences with alternatives, waste recycling, local POPs inventories, companies offering services of tire recycling as an alternative to cement kiln fuel and the problems caused by incineration and tire burning proposals in different states of the country. The program, the list of participants and a photo of part of the group is included at the end of the report.

Each participant received a folder with copies of the presentations and photocopies of other materials. After the presentations, working groups discussed two videos about the experience of zero waste in Argentina and the testimonies of communities affected by cement kiln waste burning in a video made by the American Lung Association.

As a result of the workshop a CD with the Power Point Presentations and a DVD with a selection of presentations and discussion was produced. The DVD was the result of the cooperation with the environmental group "Guerreros Verdes".

In the discussion of alternatives to prevent the burning of waste dumps and municipal landfills the participants were very interested about the Zero Waste approach presented by Cecilia Allen from GAIA based in Argentina. The participants were especially impressed that the City of Buenos Aires passed a law supporting this approach. The examples of Extended Producer Responsibility also were discussed. An NGO with more experience on municipal waste recycling based in Morelos was especially interested to incorporate the approach.

Another issue of special interest was the testimony of a new company describing the technology for the recycling of tires instead of burning them in cement kilns. This company has a facility in the state of Mexico and is planning to expand operations in the state of Chihuahua. A visit to the plant was planned but was not possible due to the holiday. The import of used tires from the USA and the agreement between the Environmental Agency of the Federal Government and the cement industry to "clean" the tires dumpsites and by burning them in cement kilns has been a matter of concern to environmental groups. In that sense the presentation from an expert from the Energy Justice Network was well received as he explained the environmental risks posed by tire burning among other types of waste.

The working groups discussed the activities each participant could do to promote disseminating more information about the POPs Convention and the risks of dioxin sources and their alternatives.

A follow-up activity included designing a poster to avoid waste burning and incineration and a fact sheet that will be printed an distributed among the participants as well as with other organizations.

The workshop was co financed with GAIA Latin America.

Follow up activities

One of the follow up activities was an invitation from the local NGO CASIFOP and Accion Ecologica from Morelos to the experts from GAIA and Energy Justice Network to meet with municipal authorities in Cuautla, Morelos and a visit to the community waste recycling experience in the municipality of Morelos. The group also visited the municipality of Tecamac which is currently confronted with a proposal for an incinerator.

Another follow up activity was the participation of RAPAM in the Foreign Relations Committee inside the National Council for Sustainable Development, an advisory body to the Environmental Secretariat (Semarnat) in their VIII Ordinary Meeting, 24 and 25 November 2005. Two recommendations proposed

by RAPAM were approved by the plenary and sent to the Semarnat demanding: a) the creation of the national coordination committee for the developing of the National Implementation Plan of the Stockholm Convention with clear mechanisms of participation of civil society: b) the promotion of non combustion technologies for used tires recycling. Unfortunately these recommendations have not been implemented by the authorities until this date.
