About the International POPs Elimination Project

On May 1, 2004, the International POPs Elimination Network (IPEN http://www.ipen.org) began a global NGO project called the International POPs Elimination Project (IPEP) in partnership with the United Nations Industrial Development Organization (UNIDO) and the United Nations Environment Program (UNEP). The Global Environment Facility (GEF) provided core funding for the project.

IPEP has three principal objectives:

- Encourage and enable NGOs in 40 developing and transitional countries to engage in activities that provide concrete and immediate contributions to country efforts in preparing for the implementation of the Stockholm Convention;
- Enhance the skills and knowledge of NGOs to help build their capacity as effective stakeholders in the Convention implementation process;
- Help establish regional and national NGO coordination and capacity in all regions of the world in support of longer term efforts to achieve chemical safety.

IPEP will support preparation of reports on country situation, hotspots, policy briefs, and regional activities. Three principal types of activities will be supported by IPEP: participation in the National Implementation Plan, training and awareness workshops, and public information and awareness campaigns.

The program of the workshop was composed and the mass media journalists from central media were invited – 5 national TVs, 4 national radio stations, 6 daily national newspapers. The officials, responsible for protection of environment in municipalities from four hot areas were invited as well. Invitations were sent to eight politicians, Members of the Parliament Committee Environment and Water, who have demonstrated active positions on environmental problems.

The workshop had four modules, each with a presentation and the following discussion.

- The first part panel history and main points of Stockholm Convention were presented. The speaker was Nevena Yordanova NM Ecoglasnost.
- The second part the participants were acquainted with the main groups of POPs and their chemical description. The speaker (Vania Dimitrova - NM Ecoglasnost) presented the main sources of POPs and she also described the contamination caused by POPs.
- The third part Professor Ada Bainova NM Ecoglasnost described the health and environmental effects of POPs. This information was verified with the data from scientific research.
- Finally the existing national legislation and strategies were briefly reviewed. This summary was presented by speaker from Ministry of Environment and Water.

The discussions after the presentations were directed mainly towards health effects of POPs, the situation in Bulgaria, control and future of the issue. The journalists were very interested in the problem. They all expressed their wish for more information on the situation in Bulgaria. The politicians made a public avowal that a big part of the information in the workshop had been new and very useful for them. The persons in charge (ecologists) from the local municipalities declared that in their regions where POPs are mainly evolved the population is not well informed by local media and responsible institutions.
